The regular meeting of the Blendon Township Board of Trustees was called to order at 6:30pm. The Purchase Orders and Cemetery Deeds were signed by the Board.

Administrator's Report: Mr. Rhoads updated the Board on the following: Mrs. Heichel and Mr. Rhoads attended the Gahanna Cart Event and are excited to get it started. Rumpke will be shadowing the deliveries. OMH is working on our new or renovation of the Administration Building.

Communications: Update Reports to the Board - Emailed from the Directors. Franklin County also advised us of our 2020 July budget, due on/by July 22, 2019.
