2. **Consent Agenda:** The regular meeting of the Blendon Township Board of Trustees was called to order at 6:30pm. Mr. Flaherty moved to approve and waive the reading of the minutes as presented for the February 7, 2018, meeting. Mrs. Heichel seconded. 3. **Signatures:** The Purchase Orders and Cemetery Deeds were signed by the Board.
4. **Administrator's Report:**
Mr. Rhoads updated the Board on the following: Plans are to attend the MORPC meeting on Thursday. Aldi plans are being reviewed and getting ready for press releases when demolition starts. Shred-It Day is April 28, Saturday. May 22, we will host the Northeast Region Collaboration, where communities in the northeast area meet to discuss future plans. 1. Director /Staff Updates:

Fire Chief Miller wanted to thank Hand & Micro Surgery Center who made a \$30K donation to the Westerville Fire Department, and in turn, have purchased a CPR device and airway equipment. The outpouring of sympathy from the community over the deaths of two Westerville Police Officers was outstanding to see and thanks to everyone for their condolences.

Mrs. Heichel discussed the Pioneer 5K Run and the proposal of Lt. Lephart. Blendon Township would like help with the rental fee for the cones and a banner, along with police support for an estimate of \$1,000.00.
