



**RESOLUTION NO. 2014-12  
A RESOLUTION ESTABLISHING THE BLENDON  
TOWNSHIP FISCAL RESERVE POLICY**

**PREAMBLE**

**WHEREAS**, It is in the public interest to have sound fiscal policy; and

**WHEREAS**, Reserve/Investments Funds are designed to allow the Township to deal with short term financial crises without bankrupting the Township; and

**WHEREAS**, the largest risk to the Township operations is the failure of a police or fire levy; therefore

**RESOLUTION**

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Township Trustees of Blendon Township, Franklin County, Ohio, that the following Resolutions be and hereby are adopted:

1. That the Board desires to increase the reserve/investment fund to four million (\$4,000,000) by the end of 2014 invested for contingency purposes.
2. The Board desires to increase the minimum reserve/investment funds to four million two hundred fifty thousand dollars (\$4,250,000) by the end of the 2015 fiscal year.
3. Additional funds may be placed in the reserve/investment fund for future obligations as deemed necessary by the Trustees and the Fiscal Officer. These may be perpetual care funds or retirement accrued benefit payments. The Blendon Township Investment Committee will review the township's financial status each year and make recommendations to the Board of Trustees on the minimum reserve/investment fund.


**BE IT FURTHER RESOLVED**, that this Resolution shall be in full force and effect immediately upon its adoption.

## Resolution 2014-18

### Resolution Requesting the Franklin County Engineers to Conduct a Speed Study on Cairo Road

The Board of Trustees of Blendon Township, Franklin County, Ohio met in regular session on October 09<sup>th</sup>, 2014, with the following members present:

James F. Welch moved the adoption of the following resolution:

WHEAREAS, the Board of Trustees of Blendon Township, Franklin County, Ohio is authorized to regulate traffic on Township roads and streets by Ohio Revised Code.

WHEAREAS, the Board has determined that the public safety and welfare of the Township would be served by conducting a study of Cairo Road;

THEREFORE, BET IT RESOLVED that the Board of Trustees hereby enacts the following:

1. The Board hereby requests the Franklin County Engineers Office to conduct a traffic study of Cairo Road to determine if stops signs at Brazzaville Road would increase safety.
2. If the findings by the Franklin County Engineers Office suggests that the stops signs will increase traffic safety that the Service Director is ordered to install such signs.
3. The Township Clerk is directed to post these regulations in five (5) conspicuous public places in the Township for thirty (30) days and publish the same in a newspaper of general circulation in the Township for three (3) consecutive weeks.
